**🐾 We LOVE animals, and most household pets are welcome in our campground. But please be mindful and respectful of the fact that not all people are comfortable around pets of various species and breeds. If another person on our property shows obvious discomfort around your pet, please do everything within your power to keep your pet distanced from that person or persons.**

**🐾 If you are the parent, guardian, or overseer of a child, please make sure neither you NOR the child approach another guest or visitor's pet or equine without the express invitation and permission of the owner. Please do not interact with or interfere with another person's pet(s) or equine(s), without express authorization AND oversight from the owner. This includes, but is not limited to, petting, pulling, tugging, pushing, brushing, or any other form of physical exchange. Parents, guardians, and overseers of minor children are responsible for ensuring children's adherence to these rules and may be held liable for any breach of policy.**

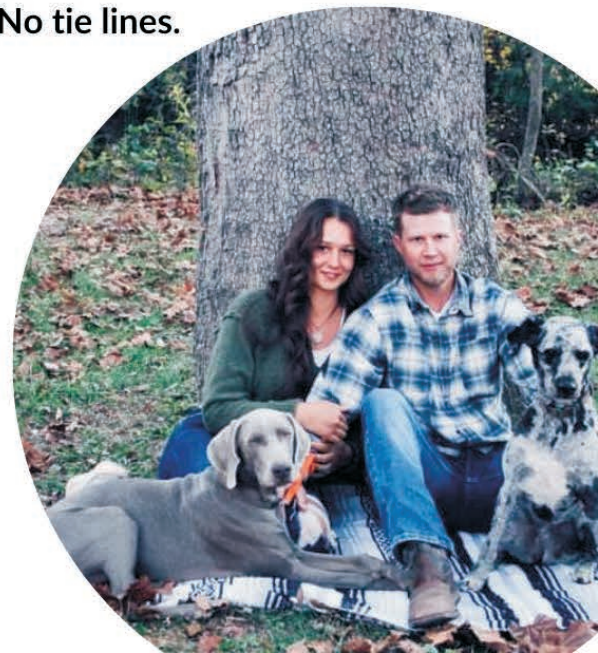
**🐾 Equines ARE allowed at Pomme de Ridge Horse Camp and Campground, with proof of current Coggins and rental arrangements made for use of horse pen(s). No tie lines.**

**🐾 If guests wish to bring more than 2 animals per site or unit rented at the campground, please call first to ensure we can accommodate additions.**

**🐾 Make sure your pet(s) are provided with adequate food, water, and shelter as needed for weather conditions.**

**We LOVE animals AND Taking Care of Our Business!**

 All dogs and household pets **MUST** be kept on a 6 ft. or less leash and under control by owner at all times when not secured in your campsite or cabin while on Sinclair Investments and Holdings, LLC property, d/b/a Pomme de Ridge Horse Camp and Campground. Pets are not to be left unattended. Ensure that your pet is not trespassing into other guest areas unless invited by those guests.

 Shock collars or other electronic devices do not meet the requirements for keeping your household pet leashed and under control. Portable fencing is allowed, as long as it is adequate for keeping your pet contained and controlled.

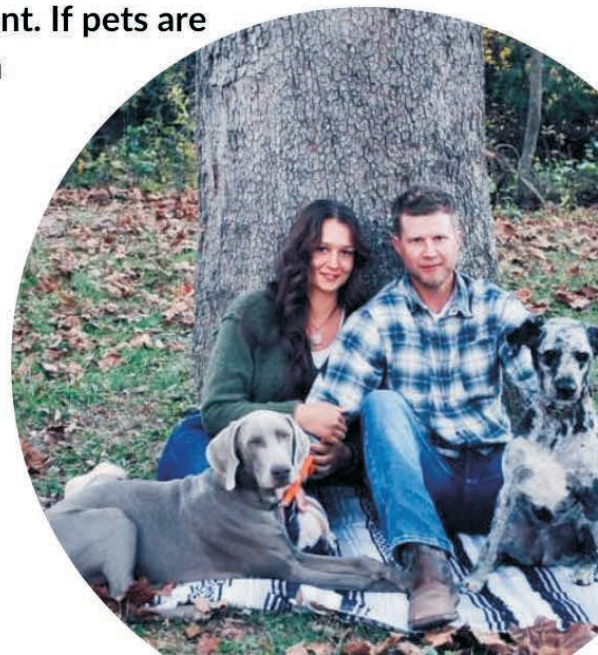
 Please escort household pets to designated or low customer traffic areas to relieve themselves. All pet owners are responsible for removing all pet waste immediately.

 Pet Fee of \$30 per pet will be charged per cabin stay up to 3 days. (This fee is **NOT** applicable to trained service dogs.) Longer stays will be charged an additional equivalent. No more than 2 dogs and/or other household pets per cabin without prior arrangement. If pets are brought and not reported/pet fees paid at or prior to check in, a \$100 pet fee policy breach per pet will be charged.

 No more than 2 dogs, cats, or other household pets per RV site, unless authorized by Pomme de Ridge Horse Camp and Campground management prior to arrival.

-  Management reserves the right to ask unruly guests or guests with unruly pets to leave.
-  Regardless of the sweet nature of your personal pet, these dog breeds (full or partial) are **NOT ALLOWED** at Pomme de Ridge Horse Camp and Campground—no exceptions: Pit Bulls, Rottweilers, German Shepherds, Dobermans, Bullmastiffs, Bull Terriers, Wolf Hybrids, American Bulldogs, or any other generally recognized aggressive breed due to hereditary aggressive nature and potential for sudden change in personality or character.
-  For the protection of, and in consideration of other persons, **ANY** animal behaving in a manner management deems noisy, aggressive, vicious, or unruly, owner must either bring their pet under maintained control or remove them from the campground immediately at management request.
-  Keep your pet quiet and controlled at all times. If your animal is a constant “barker” or loud “meower” or makes other noises that could irritate other guests, please make arrangements to board them or leave them with a trusted family or friend before coming to Pomme de Ridge Horse Camp and Campground. We want all our guests to have an enjoyable stay.
-  Horses and human riders **ONLY** on trails and trail rides. No household pets of any kind are allowed on trails and trail rides.

**🐾 ALL pets are to be properly identified, licensed, and vaccinated. Management reserves the right to demand proof of any of these requirements.**

**🐾 Damage to Sinclair Investments and Holdings, LLC property or personal property, d/b/a Pomme de Ridge Horse Camp and Campground, or Exceptional Equines, LLC personal property is subject to financial penalty, to be determined by management. This includes, but is not limited to, any injuries or damages caused by pets.**

**🐾 In addition, the owner of any pet that causes injury or damages to another person, animal, or object is expected to resolve the issue directly with the injured party or injured party of ownership. Neither Sinclair Investments and Holdings, LLC, d/b/a Pomme de Ridge Horse Camp and Campground or Exceptional Equines, LLC is responsible for any injuries or damages caused by pets.**

**🐾 Immediately report all accidents or incidents causing injury or damage to persons, property, or animals occurring on premises.**

**🐾 Trained service animals are not pets and may accompany a disabled person without payment of any pet fee or other surcharge at Pomme de Ridge Horse Camp and Campground and/or Exceptional Equines, LLC. Trained service animals are permitted in buildings, rental units, or other locations where pets may be prohibited--but must be house trained, as required by law.**
